- National ID: Passport, Driver's license or any national ID that includes a photograph and your date of birth;
- Tax number: International sellers;
- Etc.



A utility bill is any service, you pay in addition to rent, lease or mortgage provided your address. The name and address on the bill must match your registered Amazon address. You must not use a utility bill, with someone else's name, even if they are your relative. Moreover, you must provide a notarized translation of your document into English. Also translated documents must show the seal, stamp, or notarized statement, of the translator. The most important thing is to apply properly.

For instance, if something does not match the information you previously specified, Amazon.com may suspend your account for several weeks or even months. These documents must be authentic and unaltered.
