STATEMENT

We inform that reasons according to the Article 6 of the Law of Ukraine of Law Regulating the Procedure of the Departing from Ukraine and Entering into Ukraine of the Ukrainian Citizens which restrict the right of **Ivanov Stanislav Andriiovych** to depart abroad don't exist.
